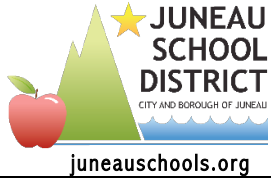
- If applications exceed the placements available, a lottery process is used for classroom placement and balance, and to develop a waiting list for any positions that may open at a later date in the school year.
